Directorate District 3 Joel Hastings, Loda, Candidate

After reviewing the bylaws, affidavits, and qualifications of the potential candidates, the EIEC 2018 Credentials Committee has determined that the candidates are eligible to serve as directors of EIEC.

Cooperative Principle: **DEMOCRATIC MEMBER CONTROL**

Cooperatives are democratic organizations controlled by their member/owners, who actively participate in setting policies and making decisions. Elected representatives are accountable to the membership. Cooperative member/owners have equal voting rights-one member, one vote.

At each annual meeting of the members, directors shall be elected by secret written ballot by the members present in person or represented by proxy. One director, and one only, shall be elected from each directorate district. Voting for directors shall be by the membership of the entire Cooperative at large and shall not be restricted to districts.

- 1. Designate the EIEC member to whom you are assigning your proxy vote. Write that member's name where it says **INSERT NAME**;
- 2. Date and sign the proxy;
- 3. Print your name and address;
- 4. Give the proxy to your designate to bring to the annual meeting.



Locate all overhead power lines.

Keep self and equipment 10 feet away from all overhead power lines.

Beware of fencing near power lines.





Carry ladders and other equipment horizontally.

Lower equipment apparatus before driving.





Never spray water near power lines.

Stay at least 35 feet away from fallen power lines.
