SUBJECT: Rates and Fees

REGULATION:

When the Cooperative provides certain services or facilities, job orders, custom work, repair of facilities, and the like, the Cooperative will bill the member/owner or non-member/owner for such based on the type of work or service at the following schedule of charges. Material item charges not specifically identified below are billed at the cost as recorded in the Cooperative's materials inventory or purchase order system. Any applicable taxes shall be added to all charges for work performed.

I. Hourly Rates

- B. Add \$60.00 material charge per 5-foot longer pole and add \$6.85 per foot for any services or primary added. No credit allowed for service or primary retired. Fees apply to single-phase construction and class 4 or smaller poles.
- C. Equipment/poles moved with no benefit to EIEC hourly rates apply.

III. Primary/Secondary Underground Subdivision Fee

- A. Fees to place underground primary/secondary in a subdivision, as defined in Regulation No. 20, Underground Electric Service Facilities, are as follows:
 - 1. Non-refundable
 - (a) Single-phase 15 kVA or lower conductor, greater than 300 feet per foot per lot charge: \$15.00 per ft.
 - (b) Pad mount transformer adder, single-phase, per transformer for rural subdivisions with 9 or fewer lots: \$750.00 per lot
 - 2. Refundable
 - (a) Subdivision deposit per lot, up to 300-foot extension: \$2,500.00 per lot

For service to a year round permanent residence, as defined in Regulation No. 25, Extension of Overhead Primary Distribution Lines, the installation fee is waived for overhead and there is a \$6.85 per foot allowance for underground construction. The Cooperative provides subsurface conduit where necessary at no additional fee.

The Cooperative will charge a single installation fee when the work order includes installing both a primary and a secondary service.

- D. Non-standard voltage transformers market price for the required unit.
- E. For service to year round permanent residence as defined in Regulation No. 25.

VI. Primary/Secondary Overhead Fees

- A. A non-refundable contribution for overhead line extensions in excess of allowances, per Regulation No. 25, shall apply.
- B. Material item prices reflect the "inventory" price or most recent purchase order price.

VII. <u>Temporary Electric Service</u>

- A. A temporary electric service that requires the installation and removal of a transformer (that will not be used for the permanent service) shall require payment of a temporary service fee of \$150.00.
- B. Bridge contractors requesting an overhead 100-amp temporary electric service shall pay a transformer service drop fee of \$400.00 plus fees for any other needed facilities.

VIII. Metering Installation

A. The charges below are based upon standard and usual line construction and metering. Non-standard items are priced on a case-by-case basis.

IX. <u>Miscellaneous Service Fees</u>

Electric service disconnection and/or reconnection service fee.

The following charges apply for each onsite or remotely initiated electric service disconnection or reconnection or for any trip made because a member fails to abide by the Cooperative's Regulations, or for a requested special service. Overtime charges apply to services performed beyond the Cooperative's regularly scheduled workday.

A. Trip Fee

Trip fee regular time \$43.00 Trip fee overtime (2 hour minimum) \$175.00

B. Meter test

The following charges apply for each requested meter test when the meter is not recording fast by more than two percent.

Single-phase meter \$43.00 Three-phase meter \$68.00

C. Dishonored check or EFT

The following charges apply for each check, credit card or electronic funds transfer (EFT) not paid or rejected by a depository institution or processor for any reason.

Dishonored check or EFT \$25.00

D. Collection fee

The following charges apply for each account that has a past due bill owing on the scheduled disconnect date. This charge covers the costs to prepare the documentation for and manage the collections process and the follow up letters.

Collection fee \$5.00

E. EFT manual processing

The following charges apply for each EFT transaction, such as check or credit card that the Cooperative manually processes in response to a phone request by a member. Automated EFT transactions and credit cards presented in person are accepted with no processing fee. The Cooperative reserves the right to limit the amount of any single credit card transaction to \$1,000.

F. Meter tampering fee

The following charges apply for instances of tampering with the operation of the Cooperative's electric meter that results in under-recording of electric power or breaking of the meter seal per Regulation No. 5, Member/Owner's Responsibility. Standard labor rates apply in addition to the administrative fee.

G. Billing and work order processing

The following charges apply for all hours required to provide account history information or cooperative documents.

H. Copy fee

The following charges apply for each single sided copy of a document provided at the request of a member/owner, representative or other interested party. A copy fee is in addition to research fees.

Black and white copy fee \$.10 per copy Color copy fee \$.25 per copy

I. Utility Pole

The utility pole attachment charge is per attachment, and is subject to contract provisions.

Per attachment \$13.18 annually

J. Material

Any materials sales are priced at the higher of inventory price or most recent purchase order price plus a 15 percent handling charge and sales tax, if applicable.

K. Outdoor Lighting

EIEC will replace a bulb, globe or photocell for an existing member owned outdoor light (dusk to dawn) installed on a cooperative pole. Charges will appear on the member/owner's bill as follows:

If the light fixture is unserviceable, EIEC will remove the fixture from the pole and will not reinstall another member owned light. EIEC will not repair any member owned lights on a building or a member owned pole. EIEC will install rental lights only on an EIEC pole.

L. Distributed Energy Resource (DER) Interconnection

Application Fee \$500.00

This fee covers administrative work, basic design evaluation, and site operation checks.

EIEC Detailed Design Evaluation Deposit \$3,000.00

This study deposit only applies to Interconnections of 100kw or less nameplate capacity which do not successfully pass basic design evaluation criteria Amount of deposit not spent on evaluation will be refunded

PPI Engineering Study Deposit Deposit schedule determined by PPI
This study deposit only applies to Interconnections of QFs of larger than 100kw nameplate capacity.
